



7. Mayor Smith opened the floor to the public:

Maryann Harrison stated she forwarded some paperwork to the solicitor and has forwarded an email to the Attorney General. She said if there is anything she can do to help with the sexual predator issues to please let her know. Nixon said he is researching to see if the village can do anything since the State has passed many laws. Maryann said she knows the Head Start has been a gray area. Keith said there is a case before the Supreme Court now and many issues are being dealt with. Maryann said we should be stricter. Keith said he is looking into it.

8. Mayor Smith asked Maryann how the stop sign on McKinley is working and she said some are running it but it is new. Holloway said he noticed flags were put on the sign on Tuesday. Maryann said it has slowed the cars down. Carbo said she thanks Maryann for her info on the sexual predators and if the village can do anything she would like to look into it. Carbo asked if the State says that Head Start falls into pre-school status and Keith said he will look into it.
9. Solicitor Nixon said he spoke to Warren County Community Services and they technically don't have to do bidding like we do. He said because the building may become public it may be that they will have to adhere to our bidding criteria. Bob said he will forward the lease agreement to the attorney. Carbo said there is a meeting the 16<sup>th</sup> with WCCS and asked if it would be discussed then and Bob said yes.
10. Bob Craig said the street committee needs to meet about the stop sign at the intersection of Section and McKinley. He said the Sheriff's Department suggests that the Mason-Morrow-Milgrove Road and St. Rt. 48 signal be modified so that the only left turn allowed is with the arrow. It was decided that he will check with the signal company to see what this would require.

Craig said that Brandstetter is following up with Tonka about the treatment plant issues. He said we want to be sure that the problem is rust and if that is it everyone agrees that the sealant will take care of it.

Bob said concerning the request to repeal the fence ordinance that there are a couple of conflicts between the ordinance and the zoning text. He said Keith can put together verbiage in the ordinance to merge the two. Mayor Smith said that a six foot chain link fence is not appropriate.

Bob said the crack sealing is on-going. Kristi said the concrete repair in Stone Brook looks good. Mayor Smith said we have a crew that has a lot of skill and we need to move forward on the Main Street Park. He asked

council to give some thought to the water feature. He said we want it to refer to our history. Carbo asked what would be first and Smith said the concrete and everything will be before the water feature. He said the proceeds from the quilt show are to go to the park next year. Mayor Smith said if any of the businesses donate to the park we can have a donor plaque.

11. Mayor Smith said we have gotten the audit drafts and we have a great review. He stated that Sharon does an excellent job.
12. Sgt. Boylan said all he has to say tonight is share with everyone that they should not leave GPS's or any valuable in their vehicles.
13. Carbo asked about the old gas station on the corner of Mason-Morrow-Milgrove and St. Rt. 48 and why it is not addressed. She stated it looks bad for all the development going on. She said we addressed the structure across the street and this needs to be as well. Dean Evans said it is owned by Carl Oeder and he will talk to him about it.
14. Sturtevant thanked Bob for the "Children Playing" sign.
15. Holloway said 131 E. Broadway has siding coming off and animals could be a problem. He also said there are some lights out on the outside of the gym. Glenn also said we need to get prices on some tables and chairs for the community center. Glenn said concerning his request about a light coming out of Stone Brook, he talked to Tony and they had the intersection blocked for two days working on concrete. He said there are lights closer together on St. Rt. 48 and he would like to look into it further. Bob said he could enquirer again but the State regulates that area. Kristi said maybe the speed limit needs to be changed to 45 mph. Keith said the only way to have the village control it is to annex it but why waste the money when ODOT can do it. Holloway said he has worked that area a long time and it is a problem. Mayor Smith said he will reach out and get all the info.
16. A motion to adjourn the meeting was made at 7:24 p.m. by Carbo, seconded by Holloway, all yeas.
